We have also focused over the last 12 months on embedding our new local chapters in SA and the ACT, supporting local events in WA, NSW and QLD and on building capability in culturally responsive regulation.

Our most significant achievement for the year was the launch of The Professional Regulator Program in February 2023. The inaugural cohort was made up of 100 participants drawn from the NRCoP corporate members. The response to the program has been overwhelmingly positive, representing an enormous vote of confidence in NRCoP, ANZSOG and the partnership with RegNet, ANU.

I would like to thank ANZSOG for its continued support of NRCoP, including the excellent contributions made by staff across the organisation. I would also like to thank the Regulatory Practice team, Dr Marion Frere, Dr Lorraine Cherney, Rosemary Vo and Shannon Tucker who work with great skill and enthusiasm to keep the NRCoP wheels turning.

## INTRODUCTION

The National Regulators Community of Practice (NRCoP) is an active network of public sector regulators from all levels of government in Australia and from every regulatory sector, professional background, role and level of seniority, who are keen to learn from and with each other. Its objectives are to support participants to become more professional and capable regulators and to promote the public value and importance of regulation as a key function of government and thereby, to deliver better citizen outcomes

This report outlines the achievements of the NRCoP from July 2022 to June 2023. This was a period of intense activity, with growing membership, a diverse program of in-person and online events and the long-anticipated launch of The Professional Regulator self-paced online course. We became experts at the hybrid event, enabling local regulators to gather together in person and enjoy the networking opportunity, but also ensuring that our national audience was able to benefit from the high calibre presentations and panel discussions. For the 100 regulators that signed up to be part of the inaugural cohort for The Professional Regulator, and for the seminar leaders based at RegNet ANU, it was a year of strengthening and extending regulatory capability. Before the end of the financial year, over 700 individuals (from 30+ member organisations) had expressed interest in making The Professional Regulator part of their development plan in 2022-23. Read on to find out more on what has been happening in the community of practice.



# **CONNECT**

To build a community of regulators across jurisdictions, sectors and roles, connecting practitioners with experts and leaders, to build regulatory expertise and improve outcomes

At its core, the NRCoP is about building connections between regulators. We support this by creating opportunities for people to get together and get to know each other and but also by creating a sense of shared purpose so that regulators feel part of a wider community. This year we have held 15 events around the country bringing together hundreds of regulators in person and thousands online. These events took place in our capital cities and our regional centres, and those who participated represented a very diverse range of regulatory spheres and included those working on the frontline to CEOs. In just a few examples, we talked about how to become a data-driven regulator in Queensland, in Western Australia we looked at the lessons from the Perth Casino Royal Commission, and in New South Wales we explored lessons from COVID on regulatory relaxation. ### **Culturally Responsive Regulation**

In 2022 the NRCoP identified building capability in culturally responsible regulation as a priority in its 3-Year Plan. To begin this journey, a panel of Indigenous regulators and leaders explored the question: What is culturally responsive regulation and how do we work with our Aboriginal and Torres Strait Islander partners to achieve it? This was followed up in February with an event in Brisbane where we heard from regulators and community members working together in culturally responsive ways, that honour Indigenous knowledge and build partnerships founded on shared decision making. NRCoP would like to acknowledge the support of the ANZSOG First Nations team in building this important program of work.

On February 14 this year, I challenged regulators in Aotearoa New Zealand and in Australia with a call to action – to continue to challenge ourselves and each other to be better, in a guest editorial I wrote for the NRCoP monthly newsletter. I challenged you to lead in culturally responsive ways and to lead by example in the way they that you work with communities in partnership and through sharing decision making. I hope that you are all on that journey, even if it is in a small way, as small steps end up making a huge difference to the journey.

Someone must have read the article (IoI) because I was then invited to host an amazing NRCoP hybrid event entitled Indigenous knowledge, partnership and shared decision making: culturally responsive regulation in action in late February. It was a chance to hear from regulators working on the ground about their efforts and experiences in working differently with Aboriginal and Torres Strait Island communities and the knowledge they hold. It was so inspiring to hear some of the practical steps being taken in different regulatory contexts and the ways in which regulators are engaging differently. The amazing panellists ranged from working in the areas of gambling, biodiscovery, drinking water to Treaty pathways. I learned a lot from that session and if you haven't already, I encourage you to watch this online. It may give you some ideas about what you could do in your own context.

I've loved watching NRCoP go from strength to strength and I congratulate you all on the forward momentum you have created in the First Nations space – both in your learning and from what you are already putting into practice. I wish you all the best as you endeavour to ensure that you hold people at the centre of your regulatory work as well look to improve outcomes in the daily lives of our two nations.

ORIC joined NRCoP in May 2023, inspired after attending its February panel discussion exploring Indigenous knowledges and partnerships.

As the regulator of some 3386 Indigenous Corporations ORIC has much to offer other regulators, drawing on its 46 years' experience in Indigenous Governance. Conversely, ORIC can greatly benefit from better understanding of and collaboration with the many regulators whom Indigenous corporations interact with. Regulation is a challenging and complex role – but it's equally rewarding. It's a role that ORIC does, committed to well-governed and self-determining Indigenous Corporations. And as Indigenous corporations evolve and mature, so should ORIC's regulatory approach. What better opportunity to do so than by being part of a diverse and vibrant community of regulatory peers.

## **Ahpra Indigenous Employment Strategy**

Ahpra aims to create a culturally safe working environment to increase Aboriginal and Torres Strait Islander employment, careers experiences and opportunities through its Employment Strategy.

The reform is driven by the National Scheme's Aboriginal and Torres Strait Islander Health and Cultural Safety Strategy 2020–2025 which seeks to eliminate racism in Ahpra and healthcare as a matter of urgency. Ahpra is progressing work on an 'Aboriginal and Torres Strait Islander Anti-Racism Policy' to provide clear expectations and guidance on how to address and respond to racism for those within or accessing the National Scheme.

Targeted recruitment campaigns to ensure representation at the highest levels have resulted in the appointment of eight new Aboriginal and Torres Strait Islander Board and committee members, bringing the current total to 33. More than 1,500 Ahpra staff have participated in the Moong-moong-gak cultural safety training program since it began in 2021.





The NRCoP greatly values the partnership with Analysis & Policy Observatory (APO) which provides the regulatory community with excellent resources in the form of a curated research collection and jobs board, both of which are well utilised by our members.

The APO Regulation Policy and Practice Collection brings together a range of relevant resources from 532 publishing organisations including national, local and state and territory Australasian governments. In addition, monitoring, inquiries and reviews are contributed by regulatory agencies and external institutions, as well as from international bodies such as the OECD and the World Bank.

Content in the Collection is arranged around four topics in focus that include regulatory strategy, regulatory instruments, government regulatory policy and sector regulation. Last year, reports related to government regulatory policy were the most popular topics in focus.

## **ENRICH**

To enrich debate on the profession of regulation and to ensure enduring benefit for regulated entities and the public

Since the Collection was established in 2020, it has had 332,415 page views and now holds over 1,900 resources. The APO monthly guest editorials have continued to be an effective way to raise awareness of a wide range of issues faced by Australian regulators.

Since we launched the Regulators Jobs Board back in April 2021, it has continued to grow in popularity and our community has used it to advertise more than 540+ positions to our 6,500+ community. During the 2022-2023 reporting period, a total of 363 jobs were placed by 47 regulatory agencies. This indicates there is increasing diversity of organisations who are using this free service. The Jobs Board continues to be a popular resource for our members, with 2,300 page views during this reporting period. If you are yet to advertise your positions via the Jobs Board, you can do so here and know you will reach a "captured audience" of 6,500+ regulators, all ready to extend their professional regulatory career.

## **EDUCATE**

To educate regulators to improve their skills and expose them to best regulatory practice to support improved outcomes

As the job of regulators has become more demanding, there has been an increased interest in professionalising practice and lifting skills of regulators at all levels. That's why the NRCoP partnered this year with the Australian National University's (ANU) School of Regulation and Global Governance (RegNet) to deliver a new self-paced online professional development program for regulators. The Professional Regulator program has been developed by regulators for regulators. The course fills a gap in Australia by providing accessible, high-quality training that has been designed with input from regulators across jurisdictions, and which focuses on their common challenges.

#### The Professional Regulator program

focuses on key areas of best regulatory practice and is for all regulators, regardless of regulatory sphere or jurisdiction. The course is a combination of six self-paced online modules and six interactive seminars in small groups. It gives participants the opportunity to learn alongside colleagues from a range of regulatory spheres across the country and is designed to be accessible and flexible.

The six modules cover:

- Who Regulates and Why
- Licensing as Regulation
- Understanding and Achieving Compliance
- Using Information to Regulate
- Regulatory Communication
- Regulatory Professionalism and Ethics

Participants can also take part in a program of six seminars that extends on the topics and themes explored in the modules.

- Using our regulatory tools
- Frontline regulators and processes
- Understanding and achieving compliance
- Regulatory information and stakeholder engagement
- Regulatory communication
- Regulatory relationships, professionalism and ethics

The Professional Regulator program was launched in February 2023, with an inaugural cohort of 100 regulators from organisations which are part of the ANZSOG-auspiced NRCoP.
